12	(c) Notice Procedure.		
13	(1) Written notice of violation shall provide at a minimum:(a) The director of public works shall keep a record of the exact date of all work caused		
14	to be done in accordance with this section on account of the act or omission of each person;		
	(b) Name and address of the owner in violation of section 17-22 and 17-23 of this chap-		
15	ter; (c) All owners of real property are responsible for removal of snow not later than Sep-		
16	tember 30th of each year and are responsible for keeping the areas free of snow		
17	through April 30th of that year; (d) Failure to remove the snow within twenty-four (24) hours will result in the city re-		
18	moving the snow and charging the owner costs of removal; (e) Owner will receive only one violation notice per season, and the city will remove the		
19	snow as needed without any additional notice to the owner. Owner bears the cost of		
20	all snow removal performed by the city.		
21	(2) Written notice of violation shall be served in the following manner:		
22	(a) If the subject property is occupied by the owner, notice shall be either personally served on such owner or mailed to such owner at the owner's last known address, by		
23	first class United States mail; (b) If the subject property is not occupied by the owner, notice shall be mailed to the		
24	owner at the owner's last known address, by first class United States mail;		
25	(c) Such notice shall be deemed complete on the day of personal service or on the day such notice is deposited in any United States post office.
